EMERGENCY HOUSING ASSISTANCE FUNDING OPEN FOR 2021

Entire application must be complete before assistance can be provided. Assistance cannot exceed \$1,500.00 and participants may only access this program once every 3 (three) years. This program serves CTSI tribal members looking to avoid foreclosure, facing eviction and those that are homeless, anywhere in the United States of America. There is no waiting list for this program. Funds will be available once funds are received each fiscal year and will be offered based on a first-come, first-served basis. When funding has been exhausted, applications will no longer be accepted. Applications are available through the Siletz Tribal Housing Department, the CTSI website and all area offices

477-Self Sufficiency Program – Essential Services during COVID

The 477-Self Sufficiency Program (SSP) is open and providing essential services to eligible families and individuals residing in the CTSI 11-County Service Area. Due to Covid-19, all tribal offices are closed to the public. We are still accepting applications and conducting appointments over the phone, through email or video conference. The SSP has prioritized the following services:

- Pre-Temporary Assistance for Needy Families (Pre-TANF) / Non-Recurrent Short Term Benefits: Siletz families below 185% of the Federal Poverty Level (FPL) may be eligible for short-term financial assistance that doesn't exceed 4 months. The financial assistance is meant to provide basic needs and address short-term emergent needs;
- Regular Temporary Assistance for Needy Families: Siletz families below the countable income limits and FPL may be eligible for monthly grant assistance to meet basic needs;
- General Assistance for Single Adults: Siletz single adults below the countable income limits and FPL may be eligible for monthly grant assistance to meet basic needs;
- Emergency Assistance: Siletz families or single adults may be eligible for support services to prevent eviction or utility shut off. Income guidelines apply;
- Classroom Training: the Program is still providing financial assistance (tuition, stipends and support services) to eligible Native Americans attending GED, Higher Education or Vocational/Occupational Training.
- Childcare Assistance: The Program offers childcare assistance to eligible TANF families while they engage in work or self-sufficiency activities;
- Foster Care Support Services: Childcare assistance to employed foster parents. The Program covers "working hours only" and limited respite.
- Home Visiting: The Program is accepting new families into the Early Childhood Home Visiting Program and working with current families to provide lessons in-person. Staff and families will be required to adhere to social distancing and wearing masks.
- Direct Placement: Support services (work clothing, transportation, tools, etc.) for Native Americans that recently gained employment. Must apply within 7-days of hire.

Other services such as Work Experience and On-the-Job Training may be available on a limited basis.

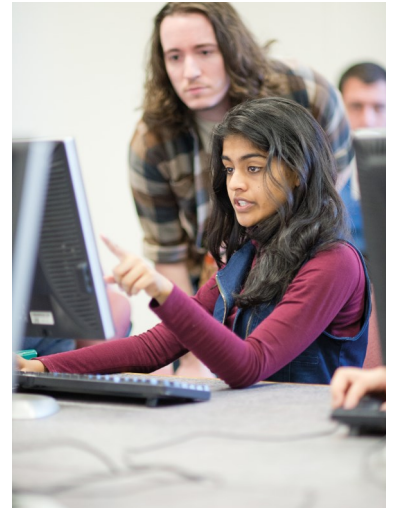

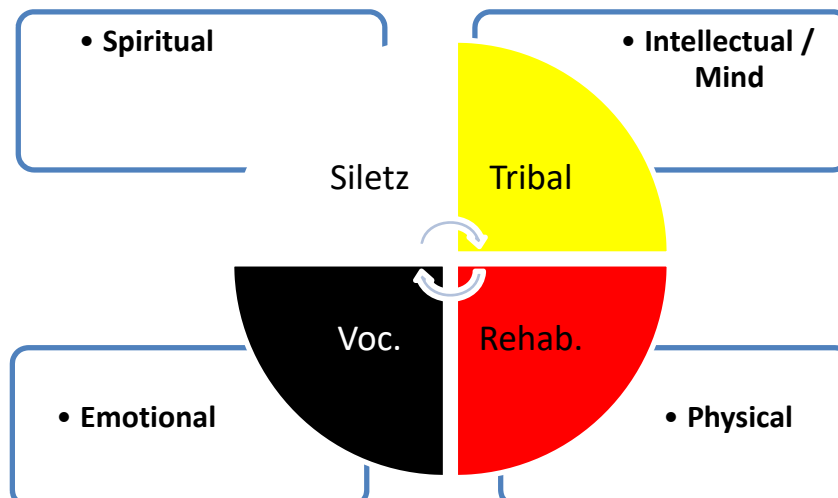

SEPTEMBER AWARENESS: PERIPHERAL ARTERY DISEASE

Peripheral Artery Disease (also called Peripheral Arterial Disease) is **a common circulatory problem in which narrowed arteries reduce blood flow to your limbs**. When you develop Peripheral Artery Disease (PAD), your legs or arms — usually your legs — don't receive enough blood flow which may lead to leg pain when walking (claudication), cold and swollen feet due to poor blood flow, and/or poor healing sores or wounds that can potentially lead to amputation, if not properly treated:

Peripheral artery disease is also likely to be a sign of a buildup of fatty deposits in your arteries (**atherosclerosis**). This condition may narrow your arteries and reduce blood flow to your legs, feet, arms, and believe it or not, your brain may get affected, ie., strokes.

Successful treatment of Peripheral Artery Disease involves exercising, eating a healthy diet, and quitting tobacco in any form. Not all people with PAD or other leg impairments will need accommodations to perform their jobs and many others may only need a few accommodations.



SIGNS AND SYMPTOMS OF PAD MAY INCLUDE:

- Painful cramping of your hips, thighs or calf muscles
- Leg numbness or weakness
- Coldness in your lower leg or foot
- Sores on your toes, feet or legs that won't heal
- A change in the color of your legs
- Hair loss or slower hair growth on your feet and legs
- Slower growth of your toenails
- Shiny skin on your legs
- No pulse or a weak pulse in your legs or feet
- Pain when using your arms, such as aching and cramping when knitting, writing or doing other manual tasks (Mayo Clinic)

If peripheral artery disease progresses, pain may occur when you're at rest or lying down. It may be intense enough to disrupt sleep. Walking around your room may temporarily relieve the pain.

If you or a loved one is experiencing signs and symptoms of PAD, please see a doctor. If this is a long-standing issue and it's impacting your work performance, then inquire of the Siletz Vocational Rehabilitation Program staff may be able to assist you with vocational rehabilitation options.

Eligibility requirements:

- **Live in 11-County Service Area**
- **Family is expecting or has an infant under twelve months of age.**
- **Enrolled Siletz Tribal member head of household or dependent child and meet one of the following criteria—**
 - **Income below 300% federal poverty level for last 30 days**
 - **Household that resides in rural location that has limited employment opportunities**
 - **First time parent**
 - **Household with at least one adult without a post-secondary certificate**
 - **Family experienced trauma, chemical dependency or mental health barriers.**
- **Other eligibility criteria may apply**

History of Tobacco

Economic history in the American colonies

In Thirteen Colonies, where gold and silver were scarce, tobacco was used as a currency to trade with Native Americans, and sometimes for official purposes such as paying fines, taxes, and even marriage license fees.

The demand and profitability of tobacco led to the shift in the colonies to a slave-based labor force, fueling the slave trade. Tobacco is a labor-intensive crop, requiring much work for its cultivation, harvest, and curing. With the profitability of the land rapidly increasing, it was no longer economically viable to bring in indentured servants with the promise of land benefits at the end of their tenure. By bringing African slaves instead, plantation owners acquired workers for long hours in the hot sun without paying them, providing only a bare subsistence to workers who could not leave or appeal to laws.

The uncultivated Virginia soil was reportedly too rich for traditional European crops, especially cereals like barley. Tobacco "broke down the fields and made food crops more productive" by depleting the soil of nutrients.

Tobacco's impact on early American history

The cultivation of tobacco in America led to many changes. During the 1700s tobacco was a very lucrative crop due to its high demand in Europe. The climate of the Chesapeake area in America lent itself very nicely to the cultivation of tobacco. The high European demand for tobacco led to a rise in the value of tobacco. The rise of value of tobacco accelerated the economic growth in America. The cultivation of tobacco as a cash crop in America marks the shift from a subsistence economy to an agrarian economy. Tobacco's desirability and value led to it being used as a currency in colonies. Tobacco was also backed by the gold standard, with an established conversion rate from tobacco to gold.

The increasing role of tobacco as a cash crop led to a shift in the labor force that would shape American life and politics up through the Civil war. In order to keep up with demand tobacco plantation owners had to abandon the traditional practice of indentured servitude in the Americas. In order to pursue maximum profits, the plantation owners turned to slavery to supply them with the cheap, fungible labor that they needed to keep up with increasing production.

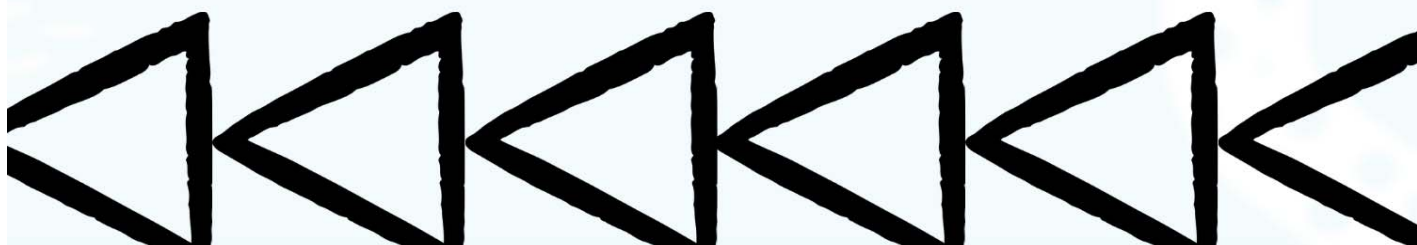

Request Your Siletz Tribal ID Card Today!

If you are unable to make it to the Administration building in Siletz to obtain or replace your Siletz Tribal ID card you are now able to request one at on of the three Area Offices; Eugene, Salem and Portland. They will take your photo and obtain your signature then send it to the Enrollment Department in Siletz. Your Tribal ID will then be mailed by CERTIFIED mail to your address on file or to the Area Office where you made your request.

If you have family that do not live in the 11-county service area or are not able to make it to a Tribal office during work hours, there is a form on the Tribal website under Government Listings > Enrollment and the tab marked "Enrollment Forms." Tribal members can print the form titled "Siletz Tribal Identification (ID) Request" and follow the directions regarding the digital photo specifications, identity verification and signature verification then mail the form to the Enrollment Department.

If you have not updated or replaced your Tribal ID card since April 1, 2016 there is a new format and more information on the card that makes it more acceptable as a form of identification with many more places. The expiration date is 10 years from the issue date. When you update your address, send in your Tribal ID card and we will mail you an updated card with your new address.



If you need to replace your card with no changes (for example address or name) within the same calendar year it was issued, there is a \$5.00 replacement fee (per Tribal Resolution #2016-087). You can obtain up to one new Tribal ID card per calendar year at no charge. Call the Enrollment Department at (800) 922-1399 ext. 1258 if you have questions about this fee.

NOTE 2: *First Distribution:* For hunters who have not been issued an early season deer archery tag (for deer tags) or any elk tag (for elk tags).

Second Distribution: For any eligible hunter, regardless of what other tags they have received.
